TRINITY CENTER COMMUNITY SERVICES DISTRICT BOARD OF DIRECTORS MEETING

Regular Meeting

July 5, 2017

The meeting was called to order by Pat Frost at 2:00 p.m. Other members present were Drew Rusnak and Mike McHugh. Fire Chief Steve Renten was also present. No members of the public were present. Board member Glen Ahmann was absent along with the General Manager.

Announcements - There were no announcements.

<u>Minutes</u> of the last meeting were posted on the website and were available at the meeting. Drew Rusnak made a motion that the minutes be accepted as written. There was a second by Mike McHugh. The minutes of the meeting were accepted unanimously as written.

CSD Financial report was made available. The balance after today's bills are paid will be \$193,116.51.

<u>TCVFD Financial</u> report was made available. The balance as of June 30, 2017 is \$71,631.92. The importance accurately recording the building fund amount on the TCVFD balance sheet was discussed.

TCVFD Auxiliary Financial report was made available. The balance as of June 30, 2017 is \$53,609.35.

Unfinished Business

<u>Approve Resolution 2017-03</u> – A resolution acknowledging Virginia Allin's service to the CSD was presented. The board expressed thanks for Virginia's many years of service. Drew Rusnak made a motion to approve Resolution 2017-03. Mike McHugh seconded. The motion passed unanimously.

<u>Board Vacancy Status Update</u> – Pat Frost received a letter of interest from Trish Wardrip. Trish currently works as the fiscal manager for the Trinity County RCD. She will be available at the August meeting for any questions from the board and/or public. If appointed, she will serve the remainder of the vacant seat and then run for re-election in November.

Communications & Director Reports

Steffanie Desrosiers read ballot information received from the CA Special District Association for election of a representative to fill Seat C. This will be discussed and acted upon by the board at the August meeting.

Also received and read by Steffanie Desrosiers was an invoice from the Trinity County Auditor for the LAFCO apportionment payments for fiscal years 15/16, 16/17 & 17/18. The county never billed the CSD for 15/16 and 16/17 but is doing so concurrently with the new fiscal year (17/18) and the amount due is \$170.11, pending approval of the LAFCO 17/18 budget on July 18. The invoice will be included for payment at the August CSD meeting.

Public Comment – None.

New Business

General Manager Report was not available.

<u>Fire Dept. Report</u> was read by Steve Renten (attached). Also, protocol was worked out with the Etna FD when calls to Scott Mtn. are received. The ambulance needed a new transmission and has been repaired by Hartnell Transmission. The TCVFD Auxiliary has been actively fundraising. The yard sale brought in ~\$6,500. The Memorial Day Pancake Breakfast had record attendance of 242 adults. Steve is working on the RCD map updates. Finally, they are implementing a 'Whereabouts Form' which will assist visitors with their location when they call for help.
